## AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous 2 articles, further providing for persons not to possess, use, 3 manufacture, control, sell or transfer firearms. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Section 6105(b) and (c)(7) and (8) of Title 18 of 8 the Pennsylvania Consolidated Statutes are amended and 9 subsection (c) is amended by adding paragraphs to read: § 6105. Persons not to possess, use, manufacture, control, sell 10 11 or transfer firearms. 12 13 (b) Enumerated offenses. -- The following offenses shall apply 14 to subsection (a): 15 Section 908 (relating to prohibited offensive weapons). 16 Section 911 (relating to corrupt organizations). 17 Section 912 (relating to possession of weapon on school 18 property). 19 Section 2502 (relating to murder).

- 3 convicted of any offense listed under subsection (b), the
- 4 following persons shall be subject to the prohibition of

- 7 (2.1) A person who has been convicted of attempt,
- 8 <u>solicitation or conspiracy to commit a violation of section</u>
- 9 2507 or 2702.1.

- 11 (7) A person who was adjudicated delinquent by a court
- 12 pursuant to 42 Pa.C.S. § 6341 (relating to adjudication) or
- under any equivalent Federal statute or statute of any other
- state as a result of conduct which if committed by an adult
- would constitute an offense under sections 2502, 2503, 2507,
- 16 2702, 2702.1, 2703 [(relating to assault by prisoner)], 2704,
- 17 2901, 3121, 3123, 3301, 3502, 3701 and 3923.
- 18 (7.1) A person who was adjudicated delinquent by a court
- 19 pursuant to 42 Pa.C.S. § 6341 or under any equivalent Federal
- 20 <u>statute or statute of any other state as a result of conduct</u>
- 21 which if committed by an adult would constitute attempt,
- 22 solicitation or conspiracy to commit a violation of section
- 23 2507 or 2702.1.
- 24 (8) A person who was adjudicated delinquent by a court
- pursuant to 42 Pa.C.S. § 6341 or under any equivalent Federal
- 26 statute or statute of any other state as a result of conduct
- 27 which if committed by an adult would constitute an offense
- enumerated in subsection (b) with the exception of those
- crimes set forth in [paragraph (7)] paragraphs (2.1), (7) and
- 30 (7.1). This prohibition shall terminate 15 years after the

- 1 last applicable delinquent adjudication or upon the person
- 2 reaching the age of 30, whichever is earlier.

- 4 Section 2. This act shall take effect in 60 days.
