AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 1 Statutes, in snowmobiles and all-terrain vehicles, further 2 providing for short title of chapter, for definitions, for 3 restricted account, for registration of dealers, for 5 registration or snowmobile or ATV, for limited registration snowmobile or ATV, for certificate of title for snowmobile or 6 ATV, for transfer to or from dealer, for transfer of snowmobile or ATV by operation of law, for issuance of new 7 8 certificate following transfer, for suspension and 9 10 cancellation of certificate of title, for application for certificate of title by agent, for perfection of security 11 interest in a snowmobile or ATV, for satisfaction of security 12 interest, for release of security interest, for assignment by 13 secured party of security interest, for snowmobile or ATV 14 15 purchased from dealer, for fees, for records, for snowmobile and ATV Advisory Committee, for operation on streets and 16 highways, for designation of snowmobile or ATV roads, for 17 special snowmobile or ATV events, for operation on private or 18 State property, for operation by persons under age sixteen, 19 for operation in safe manner, for additional limitations on 20 21 operation, for accidents and accident reports, for liability of owner for negligence, for liability insurance, for head 22 lamps and tail lamps, for breaks, for mufflers and noise 23 control, for enforcement personnel and procedures and for 24 25 penalties for violation of chapter; and making editorial 26 changes.
- 27 The General Assembly of the Commonwealth of Pennsylvania
- 28 hereby enacts as follows:
- 29 Section 1. The heading of Chapter 77 of Title 75 of the

- 3 SNOWMOBILES [AND], ALL-TERRAIN VEHICLES AND OFF-HIGHWAY
- 4 MOTORCYCLES
- 5 Section 2. Section 7701 of Title 75 is amended to read:
- 6 § 7701. Short title of chapter.
- 7 This chapter shall be known and may be cited as the
- 8 Snowmobile [and], All-Terrain Vehicle and Off-Highway Motorcycle
- 9 Law.
- 10 Section 3. The definition of "all-terrain vehicle" or "ATV"
- 11 in section 7702 of Title 75 is amended and the section is
- 12 amended by adding a definition to read:
- 13 § 7702. Definitions.
- 14 The following words and phrases when used in this chapter
- 15 shall have, unless the context clearly indicates otherwise, the
- 16 meanings given to them in this section:
- 17 "All-terrain vehicle" or "ATV." A motorized off-highway
- 18 vehicle which travels on three or more off-highway tires and
- 19 which has:
- 20 (1) a maximum width of 50 inches and a maximum dry
- 21 weight of 1,200 pounds; or
- 22 (2) a width which exceeds 50 inches or a dry weight
- which exceeds 1,200 pounds.
- 24 ATV's described in paragraph (1) may be referred to as Class I
- 25 ATV's, and ATV's described in paragraph (2) may be referred to
- 26 as Class II ATV's. This term does not include snowmobiles,
- 27 [trail bikes,] off-highway motorcycles, motorboats, golf carts,
- 28 aircraft, dune buggies, automobiles, construction machines,
- 29 trucks or home utility machines; military, fire, emergency and
- 30 law enforcement vehicles; implements of husbandry; multipurpose

- 1 agricultural vehicles; vehicles used by the department; or any
- 2 vehicle that is or is required to be registered under Chapter 13
- 3 (relating to registration of vehicles). In addition, this term
- 4 does not include off-road motor vehicles used exclusively as
- 5 utility vehicles for agricultural or business operations and
- 6 incidentally operated or moved upon the highway.
- 7 * * *
- 8 "Off-highway motorcycle" or "OHM." A motor vehicle that
- 9 meets all of the following criteria:
- 10 (1) The motor vehicle is for use off the roads and
- 11 highways of this Commonwealth.
- 12 (2) The motor vehicle has a seat or saddle for the use
- of the rider.
- 14 (3) The motor vehicle is designed to travel with not
- more than two wheels in contact with the ground.

- 1 and (ii) (B) and (C) are amended to read:
- 2 § 7706. Restricted account.
- 3 (a) Deposit and use of moneys.--
- 4 (1) The department shall deposit the following into a restricted account, which is hereby established:
- (i) all moneys received from the registration of and issuance of certificates of title for snowmobiles [and],

 ATV's and OHM's and from the issuance of vintage snowmobile permits;
 - (ii) all revenue from the sale of any publications or services relating to snowmobiles and ATV's; and
 - (iii) all fines, penalties, fees and costs assessed and collected as a result of enforcement activities conducted by the department's law enforcement personnel under this chapter.
- 16 The department shall draw moneys from the restricted 17 account for use in performing any activities necessary to 18 carry out the purposes of this chapter, including registration and certificate of title activities, training, 19 20 education, enforcement activities, construction and 21 maintenance of snowmobile [and], ATV and OHM trails and 22 acquisition of equipment, supplies and interests in land. All moneys deposited in this account shall remain in it to be 23 24 used as specified in this section.

- 26 (b) Grant-in-aid.--The department shall, upon written 27 application and subsequent approval, grant money from the 28 restricted account:
- 29 (1) To municipalities and profit and nonprofit
 30 organizations in connection with snowmobile [and], ATV and

- 1 OHM use on lands [not owned by the Commonwealth] for the
- 2 following:
- 3 (i) Plans, specifications and engineering surveys.
- 4 (ii) Fees and costs related to the preparation or performance of right-of-way lease agreements.
- 6 (iii) Land acquisition.
- 7 (iv) Construction, maintenance and rehabilitation of 8 trails and other facilities for snowmobiles [and], ATV's 9 and OHM's.
- 10 * * *
- 11 (3) To profit and nonprofit organizations for the
 12 maintenance and rehabilitation, but not the construction, of
 13 snowmobile [and], ATV and OHM trails on land owned by the
- 14 Commonwealth.
- 15 * * *
- 16 § 7711. Registration of dealers.
- 17 (a) General rule. -- A person who is in the business of
- 18 selling snowmobiles [or], ATV's or OHM's in this Commonwealth
- 19 shall register with the department as a dealer. A person who is
- 20 in the business of selling snowmobiles [or], ATV's or OHM's
- 21 outside this Commonwealth may register with the department as a
- 22 dealer.
- 23 * * *
- 24 (e) Use of dealer registration plates. -- A dealer may operate
- 25 or permit to be operated within this Commonwealth a snowmobile
- 26 [or], ATV or OHM owned by or in the possession of the dealer if:
- 27 * * *
- 28 (3) There is displayed on the snowmobile [or], ATV or
- 29 OHM in a manner prescribed by the department a valid dealer
- 30 registration plate issued to the dealer under this section

- 1 (4) The snowmobile [or], ATV or OHM is operated only for
- 2 the purpose of demonstration or testing in connection with
- 3 the dealer's business.
- 4 § 7711.1. Registration of snowmobile or ATV.
- 5 (a) General rule. -- Except as otherwise provided in
- 6 subsection (f), it is unlawful for a person to operate or for an
- 7 owner to permit another person to operate a snowmobile [or], an
- 8 ATV or OHM unless:
- 9 (1) There is carried on the snowmobile [or], ATV or OHM
- 10 a valid registration certificate issued therefor pursuant to
- 11 subsection (b).
- 12 (2) There is displayed on the snowmobile a registration
- decal, or on the ATV <u>or OHM</u> a registration plate, issued
- therefor pursuant to subsection (b).
- 15 * * *
- 16 (4) There is displayed on the snowmobile [or], ATV or
- 17 OHM a valid expiration sticker issued therefor pursuant to
- 18 subsection (b).
- 19 * * *
- 20 (b) Issuance. -- Upon receipt of an application therefor upon
- 21 a form prescribed and furnished by the department which shall
- 22 contain information reasonably required by the department and
- 23 which shall be accompanied by the required fee, the department
- 24 shall issue to the owner of a snowmobile [or], ATV or OHM:
- 25 (1) A biennial registration certificate containing the
- registration number for the snowmobile [or] $_{\perp}$ ATV or OHM and
- 27 the expiration date of the registration.
- 28 (2) A registration decal displaying the registration
- 29 number for a snowmobile or a registration plate displaying
- the registration number for an ATV or OHM.

2 (d) Expiration of registration. --

3 * * *

Upon transfer of ownership of a snowmobile [or], ATV 4 5 or OHM during a registration period, the registration 6 certificate and expiration sticker shall expire. The 7 transferor shall, within 15 days from the date of transfer, 8 return to the department the registration certificate with 9 the date of transfer and the name and address of the new 10 owner endorsed on the back. If the transferor applies for 11 registration of a different snowmobile [or], ATV or OHM and 12 pays the required transfer fee, the transferor may be issued 13 in the name of the transferor a registration certificate and 14 expiration sticker for that snowmobile [or], ATV or OHM for 15 the remainder of the registration period without payment of a 16 registration fee. The registration decal or plate shall not 17 be removed from a snowmobile [or], ATV or OHM upon transfer 18 to the new owner and is invalid until the new owner is issued 19 a registration certificate or limited registration 20 certificate for the snowmobile [or], ATV or OHM.

- 22 (f) Exemptions from registration.—Subsection (a) does not 23 apply if:
- 24 (1) The snowmobile [or], ATV or OHM is owned by or in
 25 the possession of a dealer who has been issued a dealer
 26 registration certificate, dealer registration plates and
 27 dealer plate registration cards under section 7711 (relating
 28 to registration of dealers), the dealer is in compliance with
 29 section 7711 and the snowmobile [or], ATV or OHM is used in
 30 accordance with section 7711.

- 1 (2) The snowmobile [or] ATV or OHM is owned and used by
- 2 the United States or another state or a political subdivision
- thereof, in which case the snowmobile [or], ATV or OHM shall
- 4 display the name of the owner in a manner prescribed by the
- 5 department.
- 6 (3) The snowmobile [or] ATV is operated on land owned
- or leased by the owner or operator of the snowmobile [or],
- 8 ATV $\underline{\text{or OHM}}$ and it is not operated elsewhere within this
- 9 Commonwealth.
- 10 (4) The owner of the snowmobile [or] ATV or OHM is not
- 11 a resident of this Commonwealth and the operator presents
- proof that the snowmobile [or], ATV or OHM has been properly
- registered in another jurisdiction that exempts from its
- registration requirements persons who have obtained proper
- 15 registration under this chapter.
- 16 * * *
- 17 § 7711.2. Limited registration of snowmobile [or], ATV or OHM.
- 18 (a) General rule.--It is unlawful for a person to operate or
- 19 for an owner to permit another person to operate a snowmobile
- 20 [or], ATV or OHM identified in section 7711.1(f)(3) (relating to
- 21 registration of snowmobile [or], ATV or OHM) unless:
- 22 * * *
- 23 (2) There is displayed on the snowmobile a valid
- 24 registration decal or on the ATV or OHM a valid registration
- 25 plate issued pursuant to subsection (b).
- 26 * * *
- 27 (b) Issuance. -- Upon receipt of an application therefor upon
- 28 a form prescribed and furnished by the department which shall
- 29 contain information reasonably required by the department, the
- 30 department shall issue to the owner of a snowmobile [or] ATV, or

- 1 $\underline{\text{OHM}}$ for which limited registration is required under subsection
- 2 (a):
- 3 (1) A limited registration certificate containing the
- 4 registration number for the snowmobile [or]_ ATV or OHM.
- 5 (2) A registration decal displaying the registration
- 6 number for a snowmobile or a registration plate displaying
- 7 the registration number for an ATV or OHM.
- 8 * * *
- 9 (d) Transfer of ownership. -- Upon transfer of ownership of a
- 10 snowmobile [or], ATV or OHM for which a limited registration
- 11 certificate has been issued, the limited registration
- 12 certificate shall become invalid. The transferor shall, within
- 13 15 days from the date of transfer, return to the department the
- 14 limited registration certificate with the date of transfer and
- 15 the name and address of the new owner endorsed on the back. The
- 16 registration decal or plate shall not be removed from the
- 17 snowmobile [or] ATV, or OHM upon transfer to the new owner and
- 18 is invalid until the new owner obtains a registration
- 19 certificate or limited registration certificate for the
- 20 snowmobile [or], ATV or OHM.
- 21 * * *
- 22 § 7712.1. Certificate of title for snowmobile or ATV.
- 23 (a) General rule.--Except as otherwise provided in
- 24 subsection (b), an owner of a snowmobile [or], ATV or OHM which
- 25 is in this Commonwealth and for which no certificate of title
- 26 has been issued shall apply to the department for a certificate
- 27 of title.
- 28 (b) Exemptions from titling. -- No certificate of title is
- 29 required for:
- 30 (1) A snowmobile [or] \triangle ATV or OHM that was registered

- 1 prior to the effective date of this section.
- 2 (2) A snowmobile [or], ATV or OHM owned by the United
- 3 States unless a general registration certificate has been
- 4 issued therefor.
- 5 (3) A new snowmobile [or], ATV or OHM owned by a dealer
- 6 before and until sale.
- 7 (4) A snowmobile [or], ATV or OHM owned by a nonresident
- 8 of this Commonwealth and not required by law to be registered
- 9 in this Commonwealth.
- 10 (5) A snowmobile [or] ATV or OHM owned by a resident of
- 11 this Commonwealth and required by law to be registered in
- 12 another state, based and used principally outside of this
- 13 Commonwealth and not required by law to be registered in this
- 14 Commonwealth.
- 15 <u>(6) An OHM titled by the department.</u>
- 16 (c) Contents of application. -- Application for a certificate
- 17 of title shall be made upon a form prescribed and furnished by
- 18 the department and shall contain a full description of the
- 19 snowmobile [or], ATV or OHM, date of purchase, the name and
- 20 address of the owner, a statement of the title of applicant,
- 21 together with any other information or documents the department
- 22 requires to identify the snowmobile [or] ATV or OHM and to
- 23 enable the department to determine whether the owner is entitled
- 24 to a certificate of title.
- 25 (d) Signing and filing of application. -- Application for a
- 26 certificate of title shall be made within 15 days of the sale or
- 27 transfer of a snowmobile [or]_ ATV or OHM or its entry into this
- 28 Commonwealth from another jurisdiction, whichever is later. The
- 29 application shall be accompanied by the required fee and any tax
- 30 payable by the applicant under the laws of this Commonwealth in

- 1 connection with the acquisition or use of a snowmobile [or]_ ATV
- 2 or OHM or evidence to show that the tax has been paid or
- 3 collected. The application shall be signed and verified by oath
- 4 or affirmation by the applicant if a natural person; in the case
- 5 of an association or partnership, by a member or a partner; and
- 6 in the case of a corporation, by an executive officer or person
- 7 specifically authorized by the corporation to sign the
- 8 application.
- 9 * * *
- 10 (g) Registration without certificate of title prohibited. --
- 11 Except as provided in subsection (b), the department shall not
- 12 issue a registration certificate or limited registration
- 13 certificate for a snowmobile [or], ATV or OHM or a vintage
- 14 snowmobile permit for a vintage snowmobile unless a certificate
- 15 of title has been issued by the department to the owner or an
- 16 application for a certificate of title has been delivered by the
- 17 owner to the department.
- 18 (h) Refusing issuance of certificate of title.--The
- 19 department may refuse issuance of a certificate of title if it
- 20 has reasonable grounds to believe any one of the following:
- 21 * * *
- 22 (2) Any taxes payable under the laws of this
- 23 Commonwealth on or in connection with, or resulting from the
- 24 acquisition or use of, the snowmobile [or], ATV or OHM have
- 25 not been paid.
- 26 (3) The applicant is not the owner of the snowmobile
- 27 [or] ATV or OHM.
- 28 * * *
- 29 (j) Transfer of ownership of snowmobile [or], ATV or OHM.--
- 30 (1) Upon the sale or transfer of ownership of a

- snowmobile [or], ATV or OHM within this Commonwealth, the
- 2 owner shall execute an assignment and warranty of title to
- 3 the transferee in the space provided on the certificate of
- 4 title or as the department prescribes, sworn to before a
- 5 notary public or other officer empowered to administer oaths,
- and deliver the certificate to the transferee at the time of
- 7 the delivery of the snowmobile [or], ATV or OHM.
- 8 (2) Except as otherwise provided in section 7715.1
- 9 (relating to snowmobile [or], ATV or OHM purchased from
- dealer), the transferee shall, within 15 days of the
- assignment of the certificate of title, apply for a new title
- 12 by forwarding to the department the certificate of title
- executed as required by paragraph (1), a properly completed
- 14 application for certificate of title, sworn to before a
- notary public or other officer empowered to administer oaths,
- and such other forms as the department may require.

- 18 § 7712.2. Transfer to or from dealer.
- 19 (a) Transfer to dealer.--If a dealer acquires a snowmobile
- 20 [or] ATV or OHM for the purpose of resale, a certificate of
- 21 title need not be applied for as provided for in section 7712.1
- 22 (relating to certificate of title for snowmobile [or], ATV or
- 23 OHM), but the dealer shall, within seven days from the date of
- 24 acquisition, forward to the department, upon a form prescribed
- 25 and furnished by the department, notification of the acquisition
- 26 of the snowmobile [or], ATV or OHM.
- 27 (b) Execution and display of notice of transfer. -- A dealer
- 28 making notification pursuant to subsection (a) shall execute at
- 29 least three copies of the notification, the original of which
- 30 shall be forwarded to the department, one copy to accompany the

- 1 snowmobile [or] ATV or OHM in any subsequent transfer and one
- 2 copy to be retained by the dealer for at least one year after a
- 3 subsequent transfer, to be exhibited, with the assigned
- 4 certificate of title, upon request of a police officer or
- 5 authorized department employee.
- 6 (c) Transfer from dealer.--Except as otherwise provided in
- 7 subsection (a), if a dealer transfers the dealer's interest in a
- 8 snowmobile [or] ATV or OHM:
- 9 * * *
- 10 (d) Exception for repossessed snowmobiles [or], ATV's or
- 11 OHM'S.--This section does not apply to a snowmobile [or], ATV or
- 12 OHM repossessed upon default of performance of a lease, contract
- 13 of conditional sale or similar agreement.
- 14 * * *
- 15 § 7712.3. Transfer of snowmobile [or] ATV or by operation of
- 16 law.
- 17 (a) General rule.--If the interest of an owner in a
- 18 snowmobile [or] ATV or OHM passes to another other than by
- 19 voluntary transfer, the transferee shall, except as otherwise
- 20 provided, promptly mail or deliver to the department the last
- 21 certificate of title, if available, and shall apply for a new
- 22 certificate of title on a form prescribed and furnished by the
- 23 department. The application shall be accompanied by such
- 24 instruments or documents of authority, or certified copies
- 25 thereof, as may be sufficient or required by law to evidence or
- 26 effect a transfer of title or interest in or to chattels in such
- 27 case.
- 28 * * *
- 29 (c) Surrender of certificate. -- A person holding a
- 30 certificate of title, whose interest in a snowmobile [or], ATV

- 1 or OHM has been extinguished or transferred other than by
- 2 voluntary transfer, shall immediately surrender the certificate
- 3 of title to the person to whom the right to possession of the
- 4 snowmobile [or], ATV or OHM has passed. Upon request of the
- 5 department, such person shall mail or deliver the certificate to
- 6 the department. Delivery of the certificate pursuant to the
- 7 request of the department does not affect the rights of the
- 8 person surrendering the certificate.
- 9 § 7712.5. Issuance of new certificate following transfer.
- 10 * * *
- 11 (c) Filing and retention of surrendered certificate. -- The
- 12 department shall file and retain for five years a surrendered
- 13 certificate of title, or a copy, in such a manner as to permit
- 14 the tracing of title of the snowmobile [or], ATV or OHM.
- 15 § 7712.6. Suspension and cancellation of certificate of title.
- 16 (a) Return of new snowmobile [or], ATV or OHM. -- The
- 17 department may cancel the certificate of title issued for a new
- 18 snowmobile [or], ATV or OHM if it is shown by satisfactory
- 19 evidence that the snowmobile [or] $_{\boldsymbol{L}}$ ATV or OHM has been returned
- 20 to the dealer from whom obtained.
- 21 (b) Snowmobile [or] ATV or OHM sold to nonresidents. -- The
- 22 department may cancel a certificate of title for a snowmobile
- 23 [or] ATV or OHM sold to a resident of another state or foreign
- 24 country if the snowmobile or ATV is to be registered in the
- 25 other jurisdiction.
- 26 * * *
- 27 § 7712.7. Application for certificate of title by agent.
- 28 (a) Authorization to apply. -- No person may apply for a
- 29 certificate of title on behalf of another person unless
- 30 authorization to do so is in effect and is verified by oath or

- 1 affirmation of the other person, made, except as between lessors
- 2 and fleet owners as lessees, not more than 15 days before the
- 3 application is received by the department. A lessor may
- 4 authorize a fleet owner to apply for a certificate of title for
- 5 a leased snowmobile [or], ATV or OHM for a period of up to one
- 6 year.
- 7 * * *
- 8 (c) Persons authorized to hold certificate. -- No person may
- 9 receive, obtain or hold a certificate of title recorded in the
- 10 name of another person for the other person who is not in the
- 11 regular employ of, or not a member of the family of, the other
- 12 person, unless the person receiving, obtaining or holding the
- 13 certificate of title has a valid undischarged security interest
- 14 recorded in the department against the snowmobile [or], ATV or
- 15 OHM represented by the certificate of title.

- 17 § 7712.8. Perfection of security interest in a snowmobile [or],_
- 18 ATV or OHM.
- 19 (a) Applicability of section. -- Except as otherwise provided
- 20 in 13 Pa.C.S. §§ 9311(d) (relating to perfection of security
- 21 interests in property subject to certain statutes, regulations
- 22 and treaties), 9315(c) and (d) (relating to secured party's
- 23 rights on disposition of collateral and in proceeds) and 9316(d)
- 24 and (e) (relating to effect of change in governing law), this
- 25 section provides the exclusive method of perfecting a security
- 26 interest in a snowmobile [or], ATV or OHM for which a
- 27 certificate of title is required under this subchapter.
- 28 (b) Snowmobiles [or], ATV's or OHM without Pennsylvania
- 29 certificate of title. -- If an owner creates a security interest
- 30 in a snowmobile or ATV for which a certificate of title has not

- 1 been issued by the department, the owner shall, at the request
- 2 of the secured party, promptly execute an application for a
- 3 certificate of title on a form prescribed by the department
- 4 showing the name and address of the secured party. The owner
- 5 shall tender the application, the existing certificate of title,
- 6 if any, and the required fee to the department. A security
- 7 interest in a snowmobile [or], ATV or OHM is perfected at the
- 8 time that such application, existing certificate of title, if
- 9 any, and required fee are received by the department.
- 10 (c) Snowmobiles [or], ATV's or OHM's with Pennsylvania
- 11 certificate of title. -- If an owner creates a security interest
- 12 in a snowmobile [or] _ ATV or OHM for which a certificate of
- 13 title has been issued by the department, the owner shall, at the
- 14 request of the secured party, promptly execute an application on
- 15 a form prescribed by the department showing the name and address
- 16 of the secured party. The owner shall tender the certificate of

- 10 § 7742. Brakes.
- 11 * * *
- 12 (b) ATV's and OHM's.--It is unlawful to operate an ATV or
- 13 OHM which is not equipped with a braking system which may be
- 14 operated by hand or foot, capable of producing deceleration of
- 15 14 feet per second on level ground at a speed of 20 miles per
- 16 hour, and the design must permit simple and easy adjustment to
- 17 compensate for wear.
- 18 § 7743. Mufflers and [noise] sound control.
- 19 (a) General rule. -- It is unlawful to operate a snowmobile
- 20 [or], an ATV or OHM which is not equipped at all times with a
- 21 muffler in good working order which blends the exhaust [noise]
- 22 <u>sound</u> into the overall snowmobile [or], ATV <u>or OHM</u> [noise] <u>sound</u>
- 23 and is in constant operation to prevent excessive or unusual
- 24 [noise] sound. The exhaust system shall not emit or produce a
- 25 sharp popping or crackling sound. The sound intensity produced
- 26 by a snowmobile shall not exceed 82dbA when measured in

- 4 Level of Stationary Motorcycles. The sound level intensity
- 5 produced by an ATV or OHM manufactured before January 1, 1998
- 6 shall not exceed 99dbA, or decibels, when measured at 20 inches.
- 7 The sound level intensity produced by an ATV or OHM manufactured
- 8 on or after January 1, 1998 shall not exceed 96dba, or decibels,
- 9 when measured as 20 inches.
