or registry of privately owned firearms or any list, database,_ 1 record or registry reflecting the sale, transfer or ownership of 2 those firearms. The term includes, but is not limited to, any 3 list, database, record or registry reflecting an application or 4 other record reflecting the sale or transfer of a firearm. For 5 the purposes of this definition only, the term "firearm" shall_ 6 7 include any weapon that is designed or may readily be converted 8 to expel any projectile by the action of an explosive or the 9 frame or receiver of any such weapon. * * * 10 11 Section 2. Sections 6111(b)(1.1)(v) and 6111.4 of Title 18 are amended to read: 12 § 6111. 1 pursuant to section 6105 (relating to persons not to 2 possess, use, manufacture, control, sell or transfer 3 firearms), no information on the application/record of sale provided [pursuant to this subsection] for any 4 5 firearm, as defined in subsection (f)(1), shall be retained as precluded by section 6111.4 (relating to 6 7 registration of firearms) by the Pennsylvania State 8 Police either through retention of the application/record 9 of sale or by entering the information onto a computer, 10 and, further, an application/record of sale received by 11 the Pennsylvania State Police pursuant to this subsection 12 shall be destroyed within 72 hours of the completion of 13 the criminal history, juvenile delinguency and mental 14 health records background check.

16 § 6111.4. Registration of firearms.

17 (a) General rule. -- Notwithstanding any section of this chapter to the contrary, nothing in this chapter shall be 18 19 construed to allow any government or law enforcement agency or any agent thereof to create, maintain or operate any registry of 20 21 firearm ownership within this Commonwealth[.] or to consolidate

22 or centralize any records of the:

23 (1) acquisition, transfer or disposition of firearms, or

- any portion thereof, maintained by any person; or
- 25 (2) possession or ownership of a firearm maintained by 26 any medical or health insurance entity.
- 27 (b) Penalty. -- Any government or law enforcement official who

knowingly violates section 6111(b)(1.1)(v) (relating to sale or 28

29 transfer of firearms) shall be subject to a fine of not more

than \$10,000, imprisoned for not more than 15 years or both. 30

1 (c) Definition. -- For the purposes of this section only, the term "firearm" shall include any weapon that is designed to or 2 may readily be converted to expel any projectile by the action 3 of an explosive or the frame or receiver of any such weapon. 4 Section 3. Any government or law enforcement agency or any 5 6 agent thereof that currently possesses, controls, maintains or operates a registry of firearm ownership created or compiled 7 using information on an application/record of sale provided 8 pursuant to 18 Pa.C.S. § 6111 shall destroy the registry of 9 10 firearm ownership.

11 Section 4. This act shall take effect in 90 days.
