Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in firearms and other dangerous 2 articles, further providing for the offense of persons not to 3 possess, use, manufacture, control, sell or transfer 4 firearms. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 6105(a.1)(1), (b) and (c)(2) of Title 18 of the Pennsylvania Consolidated Statutes, amended November 3, 2016 (P.L.1052, No.134), are amended to read: 10 § 6105. Persons not to possess, use, manufacture, control, sell 11 12 or transfer firearms. 13 14 (a.1)Penaltv.--15 Except as provided under paragraph (1.1), a person 16 convicted of a felony enumerated under subsection (b) [or a 17 felony under the act of April 14, 1972 (P.L.233, No.64), 18 known as The Controlled Substance, Drug, Device and Cosmetic 19 Act, or any equivalent Federal statute or equivalent statute 20 of any other state,] who violates subsection (a) commits a

- 1 felony of the second degree.

- of imprisonment exceeding two years.
- 12 (c) Other persons.--In addition to any person who has been
- 13 convicted of any offense listed under subsection (b), the
- 14 following persons shall be subject to the prohibition of
- 15 subsection (a):

- [(2) A person who has been convicted of an offense under
- 18 the act of April 14, 1972 (P.L.233, No.64), known as The
- 19 Controlled Substance, Drug, Device and Cosmetic Act, or any
- 20 equivalent Federal statute or equivalent statute of any other
- state, that may be punishable by a term of imprisonment
- 22 exceeding two years.]

- 24 Section 2. This act shall take effect in 60 days.
