Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous 2 articles, further providing for the offense of carrying 3 firearms on public streets or public property in 4 Philadelphia. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 6108 of Title 18 of the Pennsylvania Consolidated Statutes is amended to read: 10 § 6108. Carrying firearms on public streets or public property 11 in Philadelphia. 12 (a) General rule. -- No person shall carry a firearm[, rifle or shotgun] at any time upon the public streets or upon any 13 public property in a city of the first class unless: 14 15 [such] the person is licensed to carry a firearm; or 16 [such] the person is exempt from licensing under 17 section 6106(b) of this title (relating to firearms not to be 18 carried without a license).

- 21 Section 2. This act shall take effect in 60 days.
