Sections 6111(f)(2) and 6111.1(f)(3) of Title 18 of the Pennsylvania Consolidated Statutes are amended and the subsections are amended by adding paragraphs to read: 10 § 6111. Sale or transfer of firearms. 11 (f) Application of section .--12 * * * 13 14 [(2) The provisions contained in subsections (a) and (c) 15 shall only apply to pistols or revolvers with a barrel length 16 of less than 15 inches, any shotgun with a barrel length of less than 18 inches, any rifle with a barrel length of less 17

than 16 inches or any firearm with an overall length of less

than 26 inches.]

by a licensed importer, licensed manufacturer, licensed
