## A RESOLUTION

- Recognizing June 27, 2018, as "Post-Traumatic Stress Injury Awareness Day" and the month of June 2018 as "Post-Traumatic Stress Injury Awareness Month" in Pennsylvania.
- 4 WHEREAS, The brave men and women of the United States Armed
- 5 Forces, who proudly serve the United States and risk their lives
- 6 to protect our freedom, deserve the investment of every possible
- 7 resource to ensure their lasting physical, mental and emotional
- 8 well-being; and
- 9 WHEREAS, The challenges of serving in combat do not stop for
- 10 many veterans when they return home, but a new challenge begins
- 11 that many of our servicemen and servicewomen must fight every
- 12 day that causes them to struggle in silence; and
- 13 WHEREAS, The diagnosis now known as post-traumatic stress
- 14 disorder or PTSD was first defined to commonly and more
- 15 accurately understand and treat veterans who had endured severe
- 16 traumatic combat stress; and
- 17 WHEREAS, Post-traumatic stress has historically been viewed
- 18 as a mental illness caused by a preexisting flaw in the

- 1 individual's brain or character, and the term carries a stigma
- 2 that perpetuates this misconception; and
- 3 WHEREAS, Post-traumatic stress injury occurs after a person
- 4 has experienced a trauma and can result from not only the stress
- 5 of combat but also rape, sexual assault, battery, torture,
- 6 confinement or child abuse or a car accident, train wreck, plane
- 7 crash, bombing or natural disaster; and
- 8 WHEREAS, Post-traumatic stress is a very common injury to the
- 9 brain that is treatable and repairable; and
- 10 WHEREAS, Referring to post-traumatic stress injury as a
- 11 disorder perpetuates the stigma of and bias against mental
- 12 illness, and the stigma discourages those suffering from post-
- 13 traumatic stress from seeking proper and timely medical
- 14 treatment; and
- 15 WHEREAS, Making the condition less stigmatizing and more
- 16 honorable can favorably influence those affected and encourage
- 17 them to seek help without fear of retribution or shame; and
- 18 WHEREAS, Proper and timely treatment can diminish suicide
- 19 rates; and
- 20 WHEREAS, All citizens suffering from post-traumatic stress
- 21 injury deserve recognition, while those who have received these
- 22 wounds in service to our nation further deserve our respect and
- 23 special honor; therefore it be
- 24 RESOLVED, That the Senate recognize June 27, 2018, as "Post-
- 25 Traumatic Stress Injury Awareness Day" and the month of June
- 26 2018 as "Post-Traumatic Stress Injury Awareness Month" in
- 27 Pennsylvania; and be it further
- 28 RESOLVED, That the Senate commend the Adjutant General and
- 29 the Department of Military and Veterans Affairs for working to
- 30 educate service members, veterans, the families of service

- 1 members and veterans, victims of abuse, crime and natural
- 2 disaster and the general public about the causes, symptoms and
- 3 treatment of post-traumatic stress injury.
