AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in firearms and other dangerous
- articles, further providing for definitions and for sale or
- 4 transfer of firearms.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6102 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding definitions to read:
- 9 § 6102. Definitions.
- 10 Subject to additional definitions contained in subsequent
- 11 provisions of this subchapter which are applicable to specific
- 12 provisions of this subchapter, the following words and phrases,
- 13 when used in this subchapter shall have, unless the context
- 14 clearly indicates otherwise, the meanings given to them in this
- 15 section:
- 16 * * *
- 17 "Rifle." A weapon designed or redesigned, made or remade,

- 1 and intended to be fired from the shoulder and designed or
- 2 redesigned and made or remade to use the energy of an explosive
- 3 to fire only a single projectile through a rifled bore for each
- 4 <u>single pull of the trigger.</u>
- 5 * * *
- 6 <u>"Semi-automatic assault rifle." A semi-automatic rifle</u>
- 7 capable of holding more than five rounds of ammunition in a
- 8 <u>fixed or detachable magazine.</u>
- 9 "Semi-automatic rifle." A repeating rifle that utilizes a
- 10 portion of the energy of a firing cartridge to extract the fired
- 11 cartridge case and chamber the next round and that requires a
- 12 separate pull of the trigger to fire each cartridge.

- 14 Section 2. Section 6111(g) of Title 18 is amended by adding
- 15 a paragraph and the section is amended by adding a subsection to
- 16 read:
- 17 § 6111. Sale or transfer of firearms.
- 18 * * *
- 19 (c.1) Semi-automatic assault rifles. -- No person shall sell
- 20 or transfer a semi-automatic assault rifle to an individual
- 21 under 21 years of age.
- 22 * * *
- 23 (g) Penalties.--
- 24 * * *
- 25 (1.1) Any person, licensed dealer, licensed manufacturer
- or licensed importer who knowingly or intentionally sells,
- delivers or transfers a semi-automatic assault rifle to any
- 28 person, purchaser or transferee who is unqualified or
- ineligible to control, possess or use a semi-automatic
- 30 assault rifle under this chapter commits a felony of the

- 1 <u>third degree and shall in addition be subject to revocation</u>
- 2 <u>of the license to sell firearms for a period of three years.</u>

- 4 Section 3. This act shall take effect in 60 days.
