Section 5122 (relating to weapons or implements for 10 11 escape). 12 Section 5501(3) (relating to riot). 13 Section 5515 (relating to prohibiting of paramilitary 14 training). Section 2. The amendment of 18 Pa.C.S. § 6105(b) shall apply to individuals convicted or adjudicated delinquent on or after the effective date of this section for an offense subject to 18 Pa.C.S. § 6105(a).
