A RESOLUTION

- Recognizing the week of February 1 through 7, 2022, as "Gun Violence Survivors Week" in Pennsylvania.
- 3 WHEREAS, Gun violence, whether intentional or unintentional,
- 4 involves the use of a firearm to commit violent acts, such as
- 5 armed robbery, aggravated assault, suicide, homicide, domestic
- 6 violence and mass shootings; and
- 7 WHEREAS, A gun violence survivor is anyone who has personally
- 8 experienced gun violence, whether threatened or wounded with a
- 9 gun or having witnessed an act of gun violence or as a family
- 10 member or friend of someone who was wounded or killed as a
- 11 result of gun violence; and
- 12 WHEREAS, For every person who dies from gun violence, two
- 13 more survive; and
- 14 WHEREAS, Nine out of ten gun violence survivors report
- 15 experiencing trauma from the incident; and
- 16 WHEREAS, Among those persons who experienced gun violence
- 17 within the last 12 months, more than half indicated the
- 18 resulting trauma affected their well-being and ability to

- 1 function; and
- 2 WHEREAS, Half of survivors reported that they experienced gun
- 3 violence in a home, whether their own or that of a neighbor,
- 4 friend or family member; and
- 5 WHEREAS, Nurses, doctors and medical or hospital staff were
- 6 the most likely to say they experienced the impact of gun
- 7 violence through their work, followed by school employees, such
- 8 as teachers and staff; and
- 9 WHEREAS, Two-thirds of survivors are in need of mental health
- 10 services, therapy and support; and
- 11 WHEREAS, Forty-nine percent of survivors require crime victim
- 12 legal assistance; and
- 13 WHEREAS, For 40% of survivors, financial assistance is
- 14 necessary to deal with medical expenses, such as physical
- 15 therapy, rehabilitation services and surgical equipment; and
- 16 WHEREAS, Home health care is needed for one in four
- 17 survivors; and
- 18 WHEREAS, Seven percent of survivors need assistance to cover
- 19 funeral-related expenses; and
- 20 WHEREAS, Fifty-eight percent of American adults have been
- 21 impacted by gun violence in their lifetime; and
- 22 WHEREAS, Three million children are affected by gun violence
- 23 every year; and
- 24 WHEREAS, Currently, more than 1 million women living in the
- 25 United States have been shot or shot at by their significant
- 26 others; and
- 27 WHEREAS, Nearly 3.7 million women in the United States have
- 28 been threatened with a gun by their significant other; and
- 29 WHEREAS, In an average year, 1,574 families and communities
- 30 are affected by gun violence and the pain, fear and trauma

- 1 associated with it; and
- 2 WHEREAS, Gun violence rose 23% in Pennsylvania in the last 10
- 3 years; and
- 4 WHEREAS, In 2021 alone, the City of Philadelphia gained 1,846
- 5 new gun violence survivors and their families, of which 1,329
- 6 survivors were between 18 and 39 years of age; and
- 7 WHEREAS, In addition to the devastating human cost, every
- 8 year gun violence costs the Pennsylvania economy \$567 million;
- 9 and
- 10 WHEREAS, The Every Murder Is Real Healing Center in
- 11 Philadelphia provides holistic support, including grief support
- 12 groups, assistance with paperwork and court advocacy for family
- 13 members and friends left in the wake of gun violence; and
- 14 WHEREAS, Moms Demand Action is a national network of parents,
- 15 families, students and concerned citizens dedicated to keeping
- 16 families safe, encouraging responsible gun ownership and
- 17 advocating for common-sense gun safety legislation; and
- 18 WHEREAS, Moms Demand Action, along with Mayors Against
- 19 Illegal Guns, Students Demand Action and the Everytown Survivor
- 20 Network, is part of Everytown for Gun Safety, the largest gun
- 21 violence prevention organization in the country, with nearly 6
- 22 million supporters and 350,000 donors; and
- 23 WHEREAS, Everytown for Gun Safety is joined by several other
- 24 national nonprofit organizations, including the Brady Campaign
- 25 and Giffords Law Center, in the pursuit to end gun violence in
- 26 America; and
- 27 WHEREAS, A gun violence survivor described their trauma as
- 28 follows: "Dealing with the inconsistencies of healing, both
- 29 physically and emotionally. The existence of being this gray
- 30 person in a world where everyone else sees everything as black

- 1 and white. I'm either completely fine and it's over and done, or
- 2 I'm this wounded person who can never be functional the lack
- 3 of understanding that I am not really either, but some days may
- 4 be one or the other"; and
- 5 WHEREAS, "Gun Violence Survivors Week" is an acknowledgment
- 6 of the pain and suffering felt by those and their families who
- 7 survived gun violence and continue to live with that trauma; and
- 8 WHEREAS, By recognizing "Gun Violence Survivors Week," the
- 9 Commonwealth joins communities across America to raise awareness
- 10 of its broad impact on society and express empathy to those who
- 11 have endured pain as a result of a firearm; therefore be it
- 12 RESOLVED, That the Senate recognize the week of February 1
- 13 through 7, 2022, as "Gun Violence Survivors Week" in
- 14 Pennsylvania; and be it further
- 15 RESOLVED, That the Senate recognize Moms Demand Action and
- 16 other gun violence prevention organizations for their efforts in
- 17 addressing gun violence and in the pursuit of building safer
- 18 communities for the residents of this Commonwealth and citizens
- 19 of this country.
