A BILL

To prohibit Federal funding of State firearm ownership databases, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Gun Owner Registra-
5 tion Information Protection Act”.

1 **SEC. 2. PROHIBITION ON FEDERAL FUNDING OF STATE**
2 **FIREARM OWNERSHIP DATABASES.**

3 (a) DEFINITIONS.—In this section:

4 (1) STATE.—The term “State” means each of
5 the several States, the District of Columbia, the
6 Commonwealth of Puerto Rico, the Commonwealth
7 of the Northern Mariana Islands, American Samoa,
8 Guam, the United States Virgin Islands, and any
9 other territory or possession of the United States.

10 (2) STATE FIREARM OWNERSHIP DATABASE.—

11 The term “State firearm ownership database”
12 means a comprehensive or partial database of a
13 State or political subdivision of a State that lists—

14 (A) firearms lawfully owned or possessed
15 by individuals; or

16 (B) individuals who lawfully own or pos-
17 sess firearms.

18 (b) PROHIBITION.—A Federal agency may not fund
19 or otherwise support the establishment or maintenance of
20 a State firearm ownership database.

21 (c) EXCEPTION.—Subsection (b) shall not apply to
22 a database of a State or political subdivision of a State
23 that lists—

24 (1) firearms that have been reported as lost or
25 stolen; or

- 1 (2) individuals who have reported their firearms
- 2 as lost or stolen.
